### Introduction

The Data Use and Access Act 2025 introduces changes to how health and care data may be accessed, used, shared, and governed across the NHS and partner organisations. This session aims to give General Practices a clear, practical overview of the Act and walk through what actions practices need to take to remain compliant while supporting safe and effective patient care. The Act does not replace existing data laws but amends several key pieces of UK data protection and privacy legislation, simplifying rules and updating powers for modern data use.

- A **new lawful basis** for a clearer legal route for sharing
- Opportunities to support a wider range of **Research**
- Changes to when you can use **automated decision tools**
- Tightened duty to handle **complaints**
